## OFFER DESCRIPTION

Work plan: the research fellow will develop tasks within the scope of the Portuguese Dialogues project, whose main objective is to provide sources and to develop studies on Portuguese Dialogues. The activities to be performed will be as follows:

- textual edition of a dialogic work (either a printed book of c. 450 pp. or a manuscript of c. 100 fl.);
- preparation and publication of two scientific articles on Portuguese Dialogues;
- feeding and making available the "Portuguese Dialogues" database in collaboration with the webmaster;
- collaboration in the organization of two workshops open to the general public;
- development of an application for a competition for funded projects.

Duration of the fellowship: the fellowship will last for 4 months, starting in June 2022. The fellowship contract may be renewable.

Application: Applications must be submitted by email enclosing the following documents:

- Curriculum vitae (max. 5 pages) with evidence of the elements required
- Doctoral degree certificate

- In the case of academic degrees obtained in foreign HEI, it is necessary to present the recognition of the obtained degrees, in accordance with DL n° 66/2018, of 16 <sup>th</sup> of August; or, in the absence of recognition at the time of application, a declaration under oath that this recognition will be completed before contracting the Scholarship in case of being the selected candidate. It is mandatory to present the recognition until the date of contracting the scholarship.

Post-doctoral researcher in the field of Portuguese Studies - Portuguese Literature - Portuguese Dialogues.

In compliance with the provisions of article 7 of the FCT Research Grants Regulation (Reg. nº 950/2019), applicants must:

b) to have carried out the research work that led to the award of the doctoral degree in an entity other than the entity hosting the grant;

c) not exceed, with the conclusion of the scholarship contract in question, including possible renewals, an accumulated period of three years in this type of scholarship, consecutive or interpolated;

d) not have had previously a post-doctoral research fellowship contract with FCSH.

Academic degrees obtained in foreign countries require registration by a Portuguese HEI, in accordance with Decree-law n° 66/2018, of 26 <sup>th</sup> August, and Portaria n° 33/2019, of 25 <sup>th</sup> of January. The final decision must be taken within a maximum period of 60 working days after the conclusion of the prior hearing of interested parties or the public consultation.
